All documents written in a language other than Portuguese, Spanish, French, or English must be accompanied by a translation into one of these languages, duly certified by the competent authorities.

The application must be submitted with the following documents:

- Duly completed and signed application form;
- Identification document (Passport);
- Copy of the payment receipt;
- Recognition of the degree level equivalent to a Bachelor's degree with conversion of final grade - Recognition by a Portuguese public university of a foreign higher education degree and diploma (mandatory)*;
- Statement indicating the grading scale used in the country of origin (mandatory);
- Diplomas and completion certificates (academic transcript) of degree-awarding programmes, indicating the courses/units passed and respective grades, with syllabi for these units, including workload and/or ECTS, duly authenticated by the official education authorities of the respective country and recognized by the Portuguese diplomatic or consular authority in that country, or authenticated with the Hague Apostille;
- Certificates of non-degree higher education programmes (Postgraduate studies) with respective grades and syllabi, including workload and/or ECTS, duly authenticated by the

official education authorities of the respective country and recognized by the Portuguese diplomatic or consular authority in that country, or authenticated with the Hague Apostille;

- Certificate of professional training completed, with syllabus, workload, and training plan, duly authenticated by the official education authorities of the respective country and recognized by the Portuguese diplomatic or consular authority in that country, or authenticated with the Hague Apostille;
- Curriculum vitae (academic and professional);
- Request for recognition of previously acquired training and skills, with supporting documentation as required in the specific regulations, if the student wishes to obtain it;
- Group A Prerequisite (Medical declaration)
